## Introduction

The American Legion was chartered by Congress in 1919 as a patriotic veteran's organization. Focusing on service to veterans, servicemembers and communities, the Legion evolved from a group of war-weary veterans of World War I into one of the most influential nonprofit groups in the United States. Membership swiftly grew to over 1 million, and local posts sprang up across the country. Today, membership stands at nearly 2 million in more than 13,000 posts worldwide. The posts are organized into 55 departments: one each for the 50 states, along with the District of Columbia, Puerto Rico, France, Mexico, and the Philippines. (Legion, 2021)

Over the years, the Legion has influenced considerable social change in America, won hundreds of benefits for veterans, and produced many important programs for children and youth.

This history is dedicated to the American Legion Family members of Legionnaires, Auxiliary, Sons of The American Legion, and Riders who lived and enjoyed these events to the fullest! Our programs and activities support Veterans, Defense, Youth, Americanism, and Communities.

Commander Nathan Bond set the theme for his year as "Family First." This can be interpreted in several positive ways. Clearly, all American Legion component parts, from Legionnaires, Auxiliary, Sons of the American Legion, and Legion Riders, comprise one family. Also, the nuclear family.

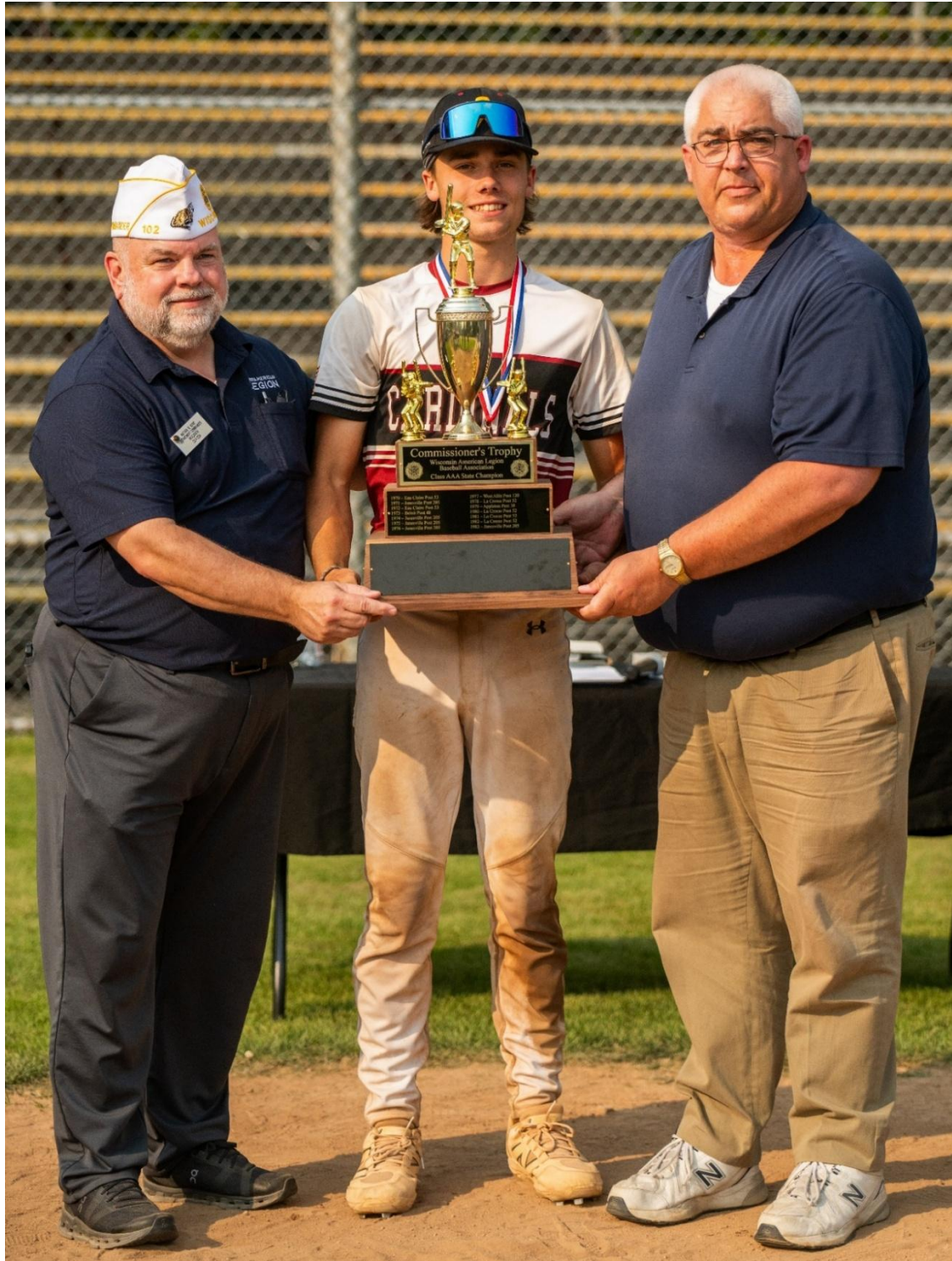

The bill promotes three goals, add official University of Wisconsin funding for the Missing-in-Action Recovery and Identification Program, increase funding for the Chippewa Falls Veterans Housing and Recovery Program, and reduce the property tax burden for veterans with an 80% or greater disability rating. Representatives from other groups, notably from the Veterans of Foreign Wars lent their voices in favor of this bill.

Testified today before the Wisconsin Senate Committee on Natural Resources, Veterans and Military Affairs, with our Legislative Committee Chair, Nathan Coward. We spoke in support of SB411 which addresses funding for the University of Wisconsin Missing In Action Recovery Identification Program, the Veterans Housing and Recovery Program, and expansion of the Disabled Veterans Property Tax Credit.

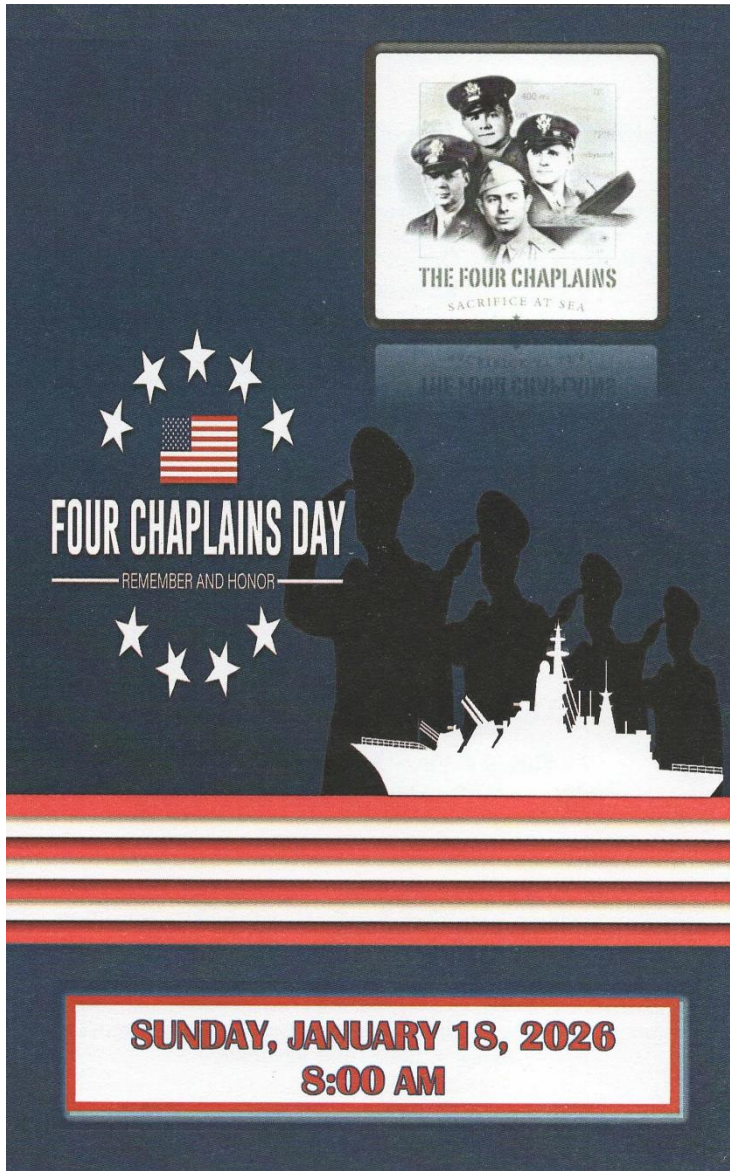

Witnesses reported that the chaplains joined arms, offered prayers, and sang hymns as the ship sank beneath them. Their calm presence provided comfort to many in their final moments.

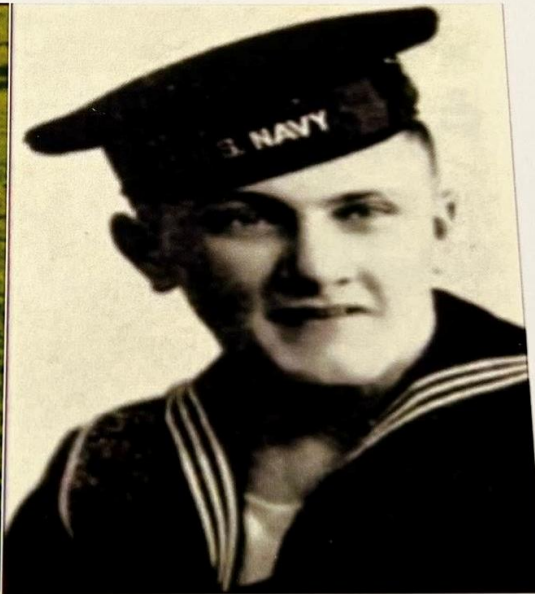
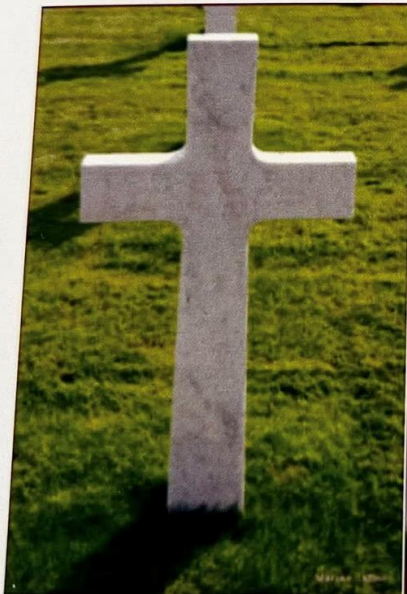




Figure 17 DVC Kohnke attended.

As the keynote speaker at the 92nd annual Pilgrimage to President Lincoln’s Tomb Thursday, American Legion National Commander Dan K. Wiley explained the unique legacy left by the 16th president.

“The abolishment of slavery remains a central part of any discussion about the life of Abraham Lincoln,” Wiley said. “Yet, he was not our first president to speak against this ugly institution. Presidents John Adams and John Quincy Adams also opposed the practice. Lincoln’s predecessor, James Buchanan, called slavery a ‘political and moral evil,’ though he supported policies to keep it in place. But Lincoln was unlike other politicians. He truly recognized not just

that slavery was wrong, but that Black people deserved the same dignity and respect as all other Americans.”

Wiley then pointed to the 14th and 15th amendments granting citizenship and expanding voting rights as part of Lincoln’s legacy that continues long after his death.

American Legion Post 32 in Springfield, Ill., has led the longest running annual observance held on Lincoln’s birthday since 1935. At least 14 departments were represented at this year’s pilgrimage.



## Commander's Biography

Wisconsin American Legion Commander, Nathan Morgan Bond, is a 25-year veteran of the US Army, who retired in 2013. Following his military service, Nathan dedicated 11 years to supporting fellow veterans as the Walworth County Veterans Service Officer, before stepping down to take a leadership role with the Wisconsin American Legion in early 2025.

I serve as the Department Historian and am a member of the American Legion Legislative Committee. I serve as Historian and Adjutant for my post, Severson-Cairns Legion Post 501 in Madison.

I welcome this opportunity to present my personal views. Today, I confine my comment to recommending that a dedicated budget be established with appropriate appropriation.

The UW MIA RIP group comprises a team of students, professors, and many others who volunteer their time to travel to sites around the globe to find and return the remains of Wisconsin soldiers lost in war. Thanks to their work, the remains of U.S. Air Force Staff Sgt. Henry Lee Stevens were recovered, positively identified, and honored at his funeral. According to information on their website, there have been four other successful repatriations.

In my current role as Executive Director of the Wisconsin Historians Association (WHA), I recommended Team Leader Konsitzke to receive the Martha Marlowe Historian Award. The WHA unanimously voted to confirm his nomination. He will receive this award at the 107<sup>th</sup> Department Convention, to be held July 15<sup>th</sup> through the 19<sup>th</sup> in Appleton, WI. Incidentally, the 108<sup>th</sup> Department Convention will be held here in Madison, July 21<sup>st</sup> to 25<sup>th</sup>, 2027.

The human impact of the UW MIA RIP program is clear. Wisconsin communities see that every possible effort is being made to bring our Wisconsin heroes home. Our institutions, people, and community are proving to veterans of the past and yet to come that our word is good. As a veteran, I am glad that our words are good.

Such beneficial work does not come free. My capitalist sense suggests that we all play a part in seeing that the UW MIA RIP group can continue its operational support, travel, and research. Please continue soliciting private donations while providing the team with coverage for basic fixed costs. I support, and I respectfully ask that you support, a dedicated budget as recommended in LRB Fiscal Estimate Number 25-5254/1 (Assembly).
